**G.S. 20-17(a)(16)** (second or subsequent conviction of larceny of motor fuel under G.S. 14-72.5).

**G.S. 20-141.5(d)** (first felony speeding to elude conviction where only two aggravating factors were present).

**G.S. 20-154(a2)** (unsafe movement resulting in property damage in excess of \$5,000 or serious bodily injury to a motorcycle or bicycle operator or passenger).

**G.S. 20-157(i)** (violation of G.S. 20-157 causing serious injury or death).

**G.S. 20-217(g1)** (first felony conviction under G.S. 20-217). **Applies to offenses committed on or after December 1, 2013.**



## KEY PROVISIONS

- No prior High Speed conviction within the last 7 years
- No motor vehicle moving violation within the prior 12 months
  - Conviction date to offense date
- Scenario:
  - Client gets a 58/35 on December 3, 2020 in Mecklenburg County
  - Client gets 97/65 on December 15, 2020 in Rowan County
  - Client gets 55/35 in school zone on March 8, 2021 in Rowan County
  - Client comes to you for advice with all 3 charges pending
  - Will Client qualify for a limited driving privilege?

# IMPAIRED DRIVING REVOCATIONS – NCGS 20-138.1

- No priors w/in 7 years = 1 year suspension
  - Immediately eligible for LDP, if 21 y/o with valid license
- 2<sup>nd</sup> DWI w/in 3 years = 4 year suspension
  - No LDP, but
  - Hearing after 2 years (NCGS 20-19(d))
- 3<sup>rd</sup> DWI and 2<sup>nd</sup> w/in 5 years = Permanent
  - No LDP, but
  - Hearing after 3 years





# IMPAIRED DRIVING PRIVILEGE

- Standard Limited Driving Privilege
  - AOC-CR-312
  - 0.14 or below
- Automatically includes:
  - Emergency medical care
  - Standard Hours for work, church, and education
  - Standard Hours for maintenance of household
  - Nonstandard hours for Community Service, Substance Abuse Classes, DES
- Must request and document:
  - Nonstandard hours for work, church, education
  - Nonstandard hours for self-employment activities

# IGNITION INTERLOCK CHANGES



## OUT WITH THE OLD

- The prior ignition interlock privilege required among other things:
  - 45 day waiting period between the date of conviction and the date of eligibility for a LDP
  - Only driving for work and calibration of the interlock machine
  - Mandatory installation on all vehicles owned by client
  - 0.04 and 0.00 alcohol concentration restrictions

# IN WITH THE NEW



## WHAT'S BEHIND THE CHANGE

- Standard DWI judgment?
  - Level 5 – 60 day suspended, 12 months unsupervised, Cost + \$100, 24 hours C/S + pay fee, C/T/P SAA + treatment, not operate until restored or granted a LDP
    - Generally, client is looking at \$1,000 in court costs, fines, and SA classes
- Sometimes the community service is required to be completed within a certain amount of time
  - 24 hours w/in 60 days
  - 48 hours with 90 days
  - 72 hours w/in 120 days

## THE LAW – S.L. 2021-182 (S 183)

- NCGS 20-179.3(c1) is repealed – this was the portion that required:
  - Wait period
  - Purpose restrictions
- NCGS 20-179.3(g3) and (g5) are amended – time and purpose restrictions
- NCGS 20-17.8(c1) – amended – vehicles required to be equipped
- NCGS 20-17.8(b)(3) – amended – alcohol concentration limit
- NCGS 20-179.5 – New – affordability of ignition interlock



## THE DETAILS – 20-179.3

- 20-179.3(c1) was repealed in its entirety.
  - 20-179.3(c1)(1) – 45 day waiting period – repealed
  - 20-179.3(c1)(2) – comply with subsection (g5) – now part of 20-179.3(g3) and (g5) – requires that the vehicle be equipped with an ignition interlock machine and that the person responsible for the machine is the one that blows into it.
  - 20-179.3(c1)(3) – repealed the purpose restrictions of the interlock privilege – so, the interlock no longer restricts driving to/from work, education, religion, SA classes, and calibration of the machine. In other words, maintenance of household and community service are now available for interlock privileges.
- These changes have already taken effect! December 1, 2021

## THE DETAILS – 20-179.3

- 20-179.3(g3) and (g5) – amended to remove the time and purpose restrictions for ignition interlock privileges
  - (g3) is discretionary/voluntary – but would essentially allow someone charged with DWI to elect to install the interlock machine to eliminate time/purpose restrictions completely
  - (g5) is mandatory – for clients that have an alcohol concentration above 0.15, the interlock is mandatory, but would also allow them to drive without time/purpose restrictions
- These changes take effect June 1, 2021.

## RESTORATION AMENDMENTS – 20-17.8

- 20-17.8 required the ignition interlock system on the following restorations:
  - Persons having a alcohol concentration of 0.15 or more
  - Persons convicted of 2 DWIs within 7 years
  - Persons sentenced at an Aggravated Level I
  - Persons restored following habitual impaired driving revocation
- 20-17.8(c1) – previously all vehicles registered to person...post June 1 = person can designate any registered vehicle they own and intend to operate
- 20-17.8(b)(3) – previously 0.04/0.00 alcohol concentration restrictions...post June 1 = 0.02 or greater for all interlock
  - Note: Under 21 y/o still subject to 0.00 alcohol concentration

## NEW LAW – 20-179.5

- Person required to install ignition interlock may apply to the vendor to waive a portion of the costs
- Person's income must be at or below 150% of the federal poverty line OR that person is enrolled in specified public assistance programs.
  - Temporary Assistance (TANF)
  - SSI
  - Supplemental Nutrition (SNAP)
  - Energy Assistance (LIHEAP)
  - Medicaid
- Waives installation/removal and 50% of monthly fee

## RARE BIRD

- NCGS 20-17.8(l) – Medical exception to Ignition Interlock
  - Physical condition that makes it impossible for the person to activate system
  - 2 or more physicians or surgeons licensed in NC or US
  - Signed certificates by the physicians
  - DMV not bound by the physicians recommendations
  - Right to appeal to a reviewing board within 10 days of denial
